Group coaching session of 3-6 people are \$40 per person per hour.

A fee of \$300.00 for a Light Sessions (available to those existing clients who are skilled at clearing energy, contain their energy and are working within their design).

required to comply with a lawful subpoena that the Client will defend, indemnify and hold me harmless of any claims. I understand that Lucinda is not liability for lawful compliance.

2. Client acknowledges and agrees that the materials being used in our sessions is for his or her personal use only and is not to be distributed, taught, used or sold to others without expressed written permission.
3. The client agrees to be mindful when endorsing and promoting the success of this partnership by sharing the RESULTS he or she has experience and not the methodology of how to use the tools.
4. The Clients agree not to intentionally or unintentionally cause harm to the guides personally life or business reputation for this work exchange. Any challenges that may arise in this business relationship shall be addressed between the two contracted parties and not in the public sector.

Referral Program:

Each new client that is referred from an existing client is entitled to a 10% discount off one service and 15% of that service goes to the referral clients next service rendered. Totaling a 25% split credit distributed between the new client and referral participant. An existing client may accumulate credit not to exceed 50% off of a service.
